

END USER AGREEMENT

IMPORTANT – PLEASE READ THROUGH THIS END USER AGREEMENT CAREFULLY BEFORE DOWNLOADING AND INSTALLING THE SOFTWARE!

BY DOWNLOADING AND INSTALLING OR OTHERWISE USING THE SOFTWARE YOU DECLARE TO HAVE READ, UNDERSTOOD AND ACCEPTED THE TERMS AND CONDITIONS SET OUT IN THIS END USER AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS OF THIS END USER AGREEMENT, YOU ARE NOT ALLOWED TO DOWNLOAD AND INSTALL, COPY OR OTHERWISE USE THE SOFTWARE.

1. This End User Agreement (“Agreement”) is a legally binding agreement between you (either as an individual or a legal entity) (“Licensee”) and Henkel AG & Co. KGaA (“Henkel”) for the software Chem-Fast Pro (“Software”).
2. Henkel herewith grants the Licensee a non-exclusive; royalty-free right to use the Software. The terms and conditions of this Agreement will also apply to any upgrades of the Software which replace and/or supplement the Software, unless such upgrades are accompanied by separate terms and conditions, in which case these later terms and conditions will apply.
3. This Agreement does not grant the Licensee any right to hand over the Software or parts of it or related documents to any third party. Furthermore this Agreement does not grant the Licensee any right to disclose any notes, notifications, or other publications relating to the Software to third parties, unless it is necessary for the intended use of the Software
4. The Licensee is not allowed to copy or modify the Software completely or partially, to unify the Software completely or partially with other products, to disassemble the Software completely or partially, to produce other software products on the basis of the Software, to lease or license the Software to third parties, or to reproduce the Software. The Licensee does not have any right in the Software’s source code or other files or information necessary for further development or modification of the Software.
5. The Licensee acknowledges that Henkel has the right to update, revise, further develop or otherwise change the Software without being obliged to provide the Licensee with the modified Software.
6. In case of breach of this Agreement by the Licensee any right to use the Software will immediately terminate without notice. Upon termination, the Licensee is obliged to destroy any copies of the Software and other related documents.
7. **The Software is provided to the Licensee on an “as is” basis. In particular but not limited to Henkel does not warrant or guarantee that the Software is free of defects, fit for a particular purpose or that the Software does not infringe any property rights or intellectual property rights of third parties. Furthermore, Henkel does not warrant or guarantee the Software is free of computer viruses. It is the sole responsibility of the Licensee to check the Software by means of suitable tools.**

Unless otherwise set out below, any claims against Henkel are excluded. This applies in particular but not limited to claims for compensation based on breach of duties under the contractual relations and based on tort. In the event of intent or gross negligence, Henkel is liable in accordance with the statutory provisions. The liability of Henkel is limited in any case to the typical and foreseeable damages provided there was no intent or omission on the part of Henkel’s statutory agents and provided that no major contractual duty has been breached. This does not affect liability under the Product Liability Act (Produkthaftungsgesetz). The aforesaid limitation of liability also does not apply in the event of harm to life, physical injury or harm to health. The extent to which liability of Henkel is excluded or limited also applies for the benefit of his employees in the event that claims are brought against them directly by the user.

8. If any provision of this Agreement is or become invalid or unenforceable, such invalidity or unenforceability shall not affect the validity of the entire Agreement. Invalid or unenforceable provisions shall be replaced by a legally valid and enforceable regulation which comes closest to the original intention of the parties.
9. This Agreement shall in all respects be interpreted in accordance with and its performance governed by the laws of the Federal Republic of Germany
10. Obligatory information in accordance with the statutory provisions:
- On this website the Licensee has the opportunity to download the Software ChemFast Pro. With this Software the Licensee may calculate the loads that can be anchored in concrete using Henkel's Chemical Anchoring Range CF800 to CF1000 under a range of different conditions. Please read this Agreement carefully before downloading and installing the Software. By downloading and installing the Software the Licensee agree to be legally bound to the terms of this Agreement.
